

## PULPIT SUPPLY LIST – PRESBYTERY OF THE MIAMI VALLEY

**Pulpit Supply Honoraria.** When a pastor leads worship for a congregation as a visiting guest, the church **shall pay mileage** at the current IRS authorized rate plus the following:

- a. For churches up to 250 members: \$100
- b. For churches over 250 members: \$125
- c. Additional compensation of \$50 for each additional service.

**Session Moderator Honoraria.** The Moderator for churches without installed pastors **shall be reimbursed mileage** at the current IRS authorized rate plus \$50.
