# Presbytery of the Miami Valley Called Special Meeting Minutes (to be approved in Sept) June 10, 2023, at 9:00 a.m. ON ZOOM

**OPENING** - RE Michael Seewer, Moderator, opened the meeting with prayer at 9:00 a.m. and reviewed zoom protocols for the commissioners. A quorum was declared. The moderator reminded the presbytery that this is a special, called meeting and nothing else can be added to this meeting.

+ Attestation to call of the meeting. In accordance with Section 4.02 of the Bylaws of the Presbytery of the Miami Valley, a special meeting of the Presbytery of the Miami Valley has been called for the purpose of examining Inquirer Josh Sweeney to move to candidacy as requested by the Committee on Preparation for Ministry, examining Candidate Bruce Miller for ordination to the Ministry of Word and Sacrament for a call at Urbana Presbyterian Church requested by the Committee on Ministry, and to elect the slate presented as requested by the Committee on Nominations.

MWS Lynn Bova, Stated Clerk reported that 13 MWS had asked to be excused and that 6 RE and 1 HR had also asked to be excused. (Appendix A)

**A MOTION** to approve 13 Excused Minister Members and seat corresponding member Candidate Bruce Miller from Presbytery of the Scioto Valley **prevailed**.

**A MOTION** to give voice to Inquirer Josh Sweeney and Candidate Bruce Miller **prevailed**. **Committee on Preparation for Ministry** chair MWS Kelley Shin introduced Inquirer Josh Sweeney and reminded the body that only questions about his call could be asked. Following the examination, a **MOTION** to approve moving Inquirer Josh Sweeney to candidacy **prevailed**. Moderator Seewer asked the required questions of the candidate and MWS Shin prayed.

Committee on Ministry chair, RE Jim Griffin, introduced Candidate Bruce Miller for ordination.

A MOTION to examine Candidate Bruce Miller for ordination as a minister of the Word and Sacrament in the Presbyterian Church (U.S.A.) pursuant to 2.07 of the Book of Order **prevailed.** Following the close of examination, a question about the terms of call prompted the stated clerk to explain that COM had met with the candidate and PNC and the terms of call had been approved although a start date is still being negotiated. The terms will be included in the COMs actions taken on behalf of presbytery in the September consent agenda. A MOTION to approve the ordination of Candidate Bruce Miller as a minister of the Word and Sacrament under G-2.0502 and G-3.0301c (a majority vote of presbytery is required) and authorize his enrollment as a member of this presbytery **prevailed.** (Appendix C & D)

# **Statement of Call - Sweeney**

God has called me to serve and love the local church as a Minister of Word and Sacrament. Since I was seventeen years old, I have worked for the church in some fashion, and predominately, that call is to work with children, youth, and young adults. I see this group in ways similar to what is learned in the parable of the Lost Sheep. For decades this group was the one lost sheep that was away and forgotten while the 99 were attended to, ensuring their needs, wants, and wishes were granted. They were pushed away from leadership, and their voices were stifled to allow "grownups" to make the decisions, and I'm not sure where that got us exactly.

As an ordained teaching elder, I look forward to serving the local church in various ways through my passion for worship, mission, and program ministry. The Book of Order states, "The focus of these affirmations is God's grace in Jesus Christ as revealed in the Scriptures. The Protestant watchwords—grace alone, faith alone, Scripture alone—embody principles of understanding that continue to guide and motivate the people of God in the life of faith."

While serving in the church, I would like to challenge my church to look again and envision the traditional education model at the local church level to motivate them to believe that we are always reforming. By looking at the entire model, I'd work with the congregation of answering the basica question of, "does it serve our people today, or are we just repeating the same process as the generation before us?" With this new thought process, I aim to inspire volunteers to renew the lens through which they think about Christian Education and where we can meet people where they are instead of the formula "if we build it, they will come."

I am passionate about working with the mission team at the local church level and abolishing the myth of the "white savior complex" and "serving poor people." I have benefited

## Statement of Faith Bruce Miller

I believe God is the creator of all things.

I believe God created all things through God's *chesed* (a Hebrew word meaning God's unique love for creation, often translated as "steadfast love"), which is beyond full human comprehension. And by God's *chesed*, God created humanity in God's image *(imago Dei)* and imputed each of us with God's goodness.

I believe the Father, Son, and Holy Spirit are the triune God, interacting in a close intimate relationship and working for the good of all things.

I believe that Jesus Christ is the Word of God incarnate, fully human, fully God.

I believe the Bible to be the written Word of God, which tells the story of God's *chesed* for all creation.

I believe God and science exist without conflict. Science is humankind's exploration of the unknown, and God's presence is in every discovery.

I believe that rebellion against God, or sin, was introduced by humanity, as depicted in the Garden of Eden, is both individual and corporate. Humanity's selfish desires reject God's original design, as demonstrated through the life of Jesus Christ. I believe the only cure for this disconnect is found in the *chesed* of Jesus Christ for all creation.

I believe that Jesus Christ is the Messiah. He died on the cross for all people, and on the third day, he was resurrected and now resides in heaven at the right hand of God.

I believe the Gospel articulates the story of Jesus' life and ministry across the ages, identifying him as the Messiah and Redeemer of all people. And that by his salvific death and resurrection, he reconciled the broken relationship between God and all humanity.

I believe confessing oneself as a Christian is admitting our shortcomings and imperfections while turning to God for mercy. Being a Christian is not passive but rather demands our highest loyalty to take up our cross, following the command of Jesus to love God and love others through action.

I believe that the Holy Spirit intercedes with humanity on God's behalf and communicates with God on humanity's behalf. The Holy Spirit is humanity's advocate and guide, continuously interacting with and speaking to us, revealing God's will for our lives.

I believe we are united in Jesus through the Holy Spirit as we celebrate the sacraments. Sharing in his life, death, and resurrection so that we will all be gathered as one family at his holy table one day.

I believe that Jesus will return one day in glory to judge all people by the *chesed* of God.

I believe that God does not change, but humanity's understanding of God continues to mature as we experience God's *chesed* through all aspects of life.

I believe the role of the Christian church is to bear witness to the *chesed* of God for all people through its active involvement in the community by loving all people and serving the least of these.
